RELEVANT DATES

NOMINATION AND APPLICATION DEADLINES:

The deadline to receive nominations is **1st May** for semester 1 and full year students and **1st October** for semester 2 students. Online application instructions are forwarded via e-mail to students upon receipt of official nominations. The deadline to complete the process is 15th May for semester 1 and full year students and 15th October for semester 2 students.

TERM DATES 2020/2021

Semester 1: Orientation week : 1st-4th September 2020/ Teaching term: 7th September-27th November 2020/ Exams: 7th to 18th December **2020**

Semester 2: Orientation week : 12th-15th January 2021/ Teaching term: 18th Jan– 23th April 2021 / Exams: 4th - 15th May 2021.



CREDITS AND GRADING: UCD uses the **European Credit Transfer System**. Modules are generally worth **5ECTS** credits each. A full semester workload is equivalent to **30ECTS** credits. Erasmus/ Exchange students can take a maximum of **30ECTS credits per semester**. Four modules is the minimum in order to be considered full-time for immigration purposes.

Students may choose from a range of over seventy modules. Further academic information can be found in the [Quinn School webpage](#). Before making the module selection, students should carefully check that they meet the recommended pre-requisites and previous learning requirement of each module.

ASSESSMENT: Business modules are taught by a series of formal lectures/classes together with a strong emphasis on course work outside of class. Each module is comprised of two to three hours of formal classes per week for a twelve-week semester. Assessment is built around the complementary understanding of theory and practice. Modules are assessed via various methods incorporating continuous assessment, individual and group project work and examinations. Formal exam assessment takes place at the end of each semester, December for semester 1 modules and May for semester 2. Repeat examinations are available at the end of the following semester.

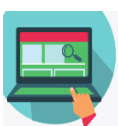
Passing grades: A, B, C, D. A letter grade is the final aggregate result of all assessment components completed for a given module. Passed grades can't be repeated.

LANGUAGE REQUIREMENTS

Language of instruction: English. Students are expected to have adequate English language skills to follow lectures and take examinations through English while in UCD.

VISA and IMMIGRATION:



Students should check the [Irish Naturalisation and Immigration Service webpage](#) for full details on application procedures and to see whether you require a visa to study in Ireland. You should also check out the website of the [Irish Department of Foreign Affairs](#) for details of the Irish Embassy attached to your country.

Registering with the Irish Naturalisation and Immigration Service (INIS): All students from outside the EU/EEA, whether you require a visa or not, must register with INIS after they have registered with UCD and before the expiry date stamped on their passport by the immigration officials at the airport. **Students must book an appointment in advance.**

WORKING IN IRELAND:

EU/EEA Nationals have the same entitlement to take up employment as that of an Irish person.

Non-EU/EEA Nationals: Students who are attending a full-time course of one year's duration are entitled to seek employment on a casual basis. Casual employment means you can work for 20 hours per week during term time or full-time (up to 40 hours) during normal college holidays. One semester students cannot seek employment. HEALTH INSURANCE:



EU Nationals in possession of the European Health Insurance Card (EHIC) are entitled to public health services in Ireland.

Non-EU Nationals: UCD doesn't arrange health insurance for students. You can purchase insurance in your home country, however you will need to ensure that it is valid in Ireland and in any other countries you plan to travel to. 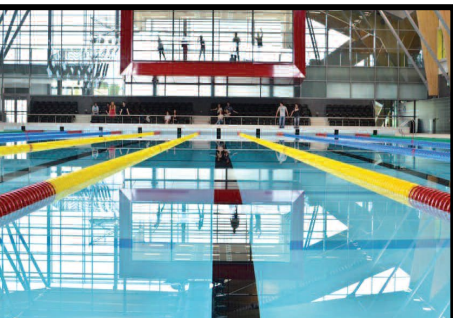
