Curriculum

Business Erasmus/Exchange students enjoy a full range of undergraduate business modules offered across the following subject areas:

- Accounting
- Banking and Finance
- Management
- HRM & Employment Relations
- Management Information Systems

Workload

Students take between 4 - 6 modules (20 - 30 ECTS) per trimester, depending on your home University requirements. Each Business module is worth 5 ECTS.

Assessment

Assessment is based on a combination of in-trimester components and formal examinations which take place at the end of each trimester, December for Autumn modules and May for Spring modules. A grade of D- or higher is a passing grade.

Language of Instruction

Students are expected to have adequate English language skills to follow lectures and take examinations through English while in UCD. English language guidelines can be found on the [UCD Admissions website](#).

IT Requirements

Visa and Immigration

Some students may require an entry visa for Ireland. Students are advised to check the Irish Naturalisation and Immigration Service website to establish if they require a visa. Further information can be found in the Immigration section of [UCD Global Office website](#).

Health Insurance

Irish Naturalisation Immigration Bureau (INIS) regulations state that students from outside the EU/EEA must obtain private health insurance meeting certain requirements. UCD does not arrange health insurance for students.

Students from EU Member States in possession of the European Health Insurance Card (EHIC) are entitled to public health services in Ireland. The EHIC card is available from the health authorities in your home country.

Accommodation

On-campus accommodation is available at both the Belfield and Blackrock campus. UCD has set aside a large proportion of on-campus rooms for international students. However, places are limited and as a result UCD can't guarantee on campus accommodation to all international students.

Application & Deadlines

Students need to be nominated to UCD by their Home University. Application takes place online upon receipt of nomination.

Autumn trimester/ full academic year:

Nomination deadline: 1st May

Application deadline: 15th May

Spring trimester:

Nomination deadline: 1st October

Application deadline: 15th October
